## Ordering

You can order our products from the Web Store of Union Medico. By placing an order with Union Medico you automatically accept the Terms and Conditions of Union Medico. By placing an order on this Website you warrant Union Medico to be at least 18 years of age. If Union Medico reasonable believes that you are not legally entitled to order a product, we reserve the right to cancel your order. Union Medico only sells products to individuals who can purchase with a credit card or pay an invoice. Union Medico reserves the right to refuse access to the Website, terminate accounts, remove or edit content or cancel orders at our discretion.

When you have placed an order at our Web Store, you will receive an e-mail from Union Medico acknowledging that we have received your order. This does not mean that your order has been accepted as all orders are subject to acceptance by Union Medico and are subject to availability. You will receive an acceptance of your order only when the purchased products have been dispatched (shipping confirmation). The contact only relates to products whose dispatch we have confirmed in the shipping confirmation.

## Payment and prices

The price of any product will be as displayed on our Website. These prices do not include delivery costs and payment fees, which will be added to the total amount due.

Union Medico accepts payment from your credit card when you place an order at the Web Store. Making purchases in our Web Store is secure (SSL). We use state of the art technology to keep your credit card information safe. Orders will only be effective, after your complete payment transfer has been received, and you have accepted the Terms and Conditions described here.

All prices on the Website are stated in Euros. All countries within the European Union are shipped on a Delivery Duty Paid (DDP) basis, which means that taxes and duties are included in the price at checkout. Countries outside the European Union are shipped on a Delivery Duty Unpaid (DDU) basis, which means that the prices displayed are exclusive of all taxes and duties, as well as Danish VAT. International orders are subject to and may incur taxes and duties as determined by the customs agency within the destination country.

The payment is only withdrawn from your account when the product has been dispatched by Union Medico.

## Delivery

When you have received the order confirmation, the time of delivery will be between 2 to 7 days depending on the final destination. If the product that you order is out of stock, we will inform you of this on the invoice and you will thus only pay for the products that you have received.

In case Union Medico has reason to question the buyers solvency or ability to pay for delivered products, Union Medico has no obligation to make delivery and shall be entitled to stop products under carriage.

## Returns

Union Medico accepts returns. You must within 14 days after you have received the goods inform us that you wish to return the goods to us. The goods must be returned to us not later than 14 days after you have informed us that you wish to make use of your right to return the goods. The goods must be returned to the address at the bottom of this page. You are responsible for the return expenses. The goods can be returned even in the case where the goods have been used. When we receive the returned goods, it will undergo a quality control, where we will assess the quality of the goods and if the goods have not been impaired the purchase sum will be reimbursed in full to your credit card. If the value of the goods has been impaired the full amount except for the impairment will be reimbursed to your credit card. Union Medico does not accept returns in relation to goods such as medico equipment or medicine that for health protection or hygiene reasons are not suitable to be resold to another buyer. These goods will for security and health reasons be sold in a sealed package and when that sealing has been broken by the buyer, the purchase sum will not be reimbursed to the buyer.

## Shipment

## Damaged goods
